**Explanation of Responses:**

("Issuer") Common Stock ("Common Stock"), for no additional consideration, if the volume weighted average price of Common Stock over twenty trading days within any thirty trading day period during the Earn-out Period (as defined in the Business Combination Agreement) was greater than or equal to (1) \$12.50, (2) \$15.00, and (3) \$18.00. The reporting person's right to receive shares pursuant to this earn-out right became fixed and irrevocable on August 9, 2022, the effective date of the Business Combination.
- Each share of phantom stock is the economic equivalent of one share of Wag! Group Co. Common Stock.
